#### **ROLL CALL**

### **President's Report**

The Education & Training Coordinator could not confirm why it did not appear in the accounts but perhaps because it had not gone through probate? She could however announce that the first decision on use of the funds had been made at Committee meetings at Summer School - some of the money will be used to meet future candidates' fees, for both Unit and CTI examinations, so candidates do not have to meet this expense. After a productive discussion with teachers at this Summer School, other initiatives will be introduced, making use of the fund.

### 3. Honoria and payments for Management Committee position holders

### Part A: Honoraria

The honoraria were agreed by the Management Committee, at a half-day facilitated meeting, as appropriate in relation to the report written by Liz Hickey in 2016. Like the expenses for summer meetings in Part B below, they strike a balance between benefit to the officials and benefit to the Branch.

Wellington spoke against the reduction in honoraria for the Secretary and Treasurer, in view of the workload they carry.

### Part B: Management Committee expenses for summer meetings and AGM for 2023 Financial Year

There was a substantial discussion about this Notice of Motion. The intention is to reduce the number of Management Committee meetings required at Summer School, while allowing for

Management Committee members to be reimbursed for attendance at these meetings and the AGM if they wish to claim. It was agreed that if Management Committee is required to attend further meetings, reimbursement may be claimed. Overall costs to the NZ Branch will therefore be reduced.

The question was raised, how do the reductions fit in with last year's remit to ensure people are not out of pocket for participating in the management of the Branch, i.e., what has changed in the thinking?

Katharine Hoskyn pointed out that the Notice of Motion reflects what consultants have recommended; if a member of the Management Committee is required longer at Summer School, e.g. for Education and Training activities, they will be entitled to claim for the cost of additional days or the whole of Summer School. It continues to be accepted that no-one should be out of pocket as a result of the proposed changes. Auckland will monitor this, and that the Management Committee is doing what is expected of it.

A number of points were raised:

- It is a huge advantage for people to meet the Branch officials face to face at Summer School it is not just about meetings.
- Zoom meetings have their place, but do not have all the advantages of face-to-face meetings.
- There may be more difficulty recruiting officers without some financial incentive.
- Concern about logistical issues regarding the accommodation provider and cost of a vacant room if some of the Management Committee leave Summer School after the series of meetings. (This may not be the case if sufficient warning is given)

### PROPOSED BUDGET

It was noted that the budget was distributed close to the end of the year, and the Delegates have not all been instructed how their Regions would vote. The President apologised on behalf of the NZ Branch for the late distribution of the proposed budget. The Constitution does not require that the AGM accept the budget, and so it was agreed to 'note' the Budget rather than vote on it.

### 2. Branch Constitution – Amendments to the maximum term of office for Management Committee members

Elaine Laidlaw spoke to this Notice of Motion, followed by some discussion. The question was asked, would the terms of different Committee members overlap? Most years, there will be a few changes to the Committee, and the number of changes will depend on the length people chose to stay on the Committee - they commit to one year, and may stay for one, two or three years (or now under exceptional circumstances, four).

### 3. Branch Constitution – Amendments to reflect change to the Incorporated Societies Act + two amendments

Branch Constitution – Amendments to reflect change to the Incorporated Societies Act Proposer: Jeanette Watson Seconder: Debbie Roxburgh

Minor amendments to Notice of Motion Branch Constitution – Amendments to reflect change to the Incorporated Societies Act

Jeanette Watson explained that the minor corrections were of a typographical nature only and did not change the intent of the Notice of Motion nor would the Notice of Motion itself interfere with implementation of Notices of Motion relating to one-person, one-vote. Furthermore, Management Committee wanted to embark now on work to comply with changes to the Act as it is a substantial piece of work and it takes time to get changes made via the AGM schedule. Legal advice has been sought from lawyer and Scottish country dancer, Chris Kelly. Acceptance of the amendment relating to Minor amendments to Notice of Motion Branch Constitution – Amendments to reflect change to the Incorporated Societies Act was put to the vote.

Voting: FOR 27 AGAINST 7 ABSTENTIONS 0 CARRIED

Amendment to Notice of Motion re Branch Constitution Proposer: Vicky Heslop Seconder: Kelly Walker

Noleen Harper put forward changes in the wording of the amendment, changes which were

provided by the proposer and seconder. Discussion concluded that the suggested changes did not alter the intent of the amendment, and acceptance of the amendment with its original wording (see Appendix 2) was put to the vote.

Voting: FOR 26 AGAINST 8 ABSTENTIONS 0 CARRIED

Acceptance of the Notice of Motion together with its two amendments was put to the vote.

Voting: FOR 27 AGAINST 7 ABSTENTIONS 0 CARRIED

Katharine Hoskyn thanked Jeanette Watson and others for the enormous amount of work they had put into this.

## 4. Alteration to the Constitution to enable one-person, one-vote for determination of Branch fees and expenses for Office Bearers

Proposer: Katharine Hoskyn Seconder: Antanas Procuta

Katharine Hoskyn outlined the background to this Notice of Motion, which was initiated four years ago, and now needs a two thirds majority in favour to proceed. It will allow each Member to be heard. The process for one-person, one-vote voting will be: 1) A Notice of Motion will be sent out to Members along with instructions for voting and 2) The Member may vote on-line or by post by a specified date well before the AGM. If the Motion is not carried, i.e. Members vote "no", the Proposer (in this case the Management Committee) will have time to amend the Motion. No one Region will be able to dominate the voting, and current protections will continue.

In the discussion that followed, other points raised were;

- The delegate system is outdated, and there are now tools to allow all Members to vote.
- This is about encouraging active, engaged Branch Members.
- People who can't get to Region meetings, where the Delegates are instructed, are not necessarily uninvolved (although they may be).
- Members need to understand fully what they are voting for, hence they need opportunities to discuss any Notice of Motion; some newer Members may have difficulty with Branch operation
- Hence Branch AGM papers need to be sent out early to <u>Members</u>, as well as to Regions, in order to be able to discuss any Notice of Motion at Region meetings (i.e. six weeks prior to the AGM is too late).
- Those who don't want to vote can abstain; this will work better for those who do want to.
- There remains work to be done on setting a minimum number of respondents (quorum) to ensure fair representation; there are ways to do this; noted the response to Auckland's recent online survey was well short of 25%.
- Much of the voting process will not change.

Voting: FOR 27 AGAINST 7 ABSTENTIONS 0 CARRIED

Pat Henley thanked Katharine Hoskyn and Antanas Procuta for the work they had put into this, over the last four years.

### 5. Alteration to the Constitution to enable one-person, one-vote for voting on Notices of Motion

Proposer: Katharine Hoskyn Seconder: Antanas Procuta

Katharine explained that this Notice of Motion applies to ordinary matters, for example for ideas generated by Regions, and does not apply to voting on complex constitutional matters. The system of delegate voting will continue for complex constitutional matters.

### Additional questions raised:

- Would the result of the online voting be binding?
- What happens if the Members vote, "no" and the AGM decides otherwise?
- How would multiple amendments be handled?

### Right of reply (Katharine Hoskyn)

- This is all about hearing Members' views, and those views would need to be accepted.
- The Chair will still have the right to decide how amendments will be handled.
- The need for amendments will be reduced by discussion.
- If something is seriously wrong, there are mechanisms within the Constitution to address it.

### **FUTURE SUMMER SCHOOLS**

### Nelson 2023-2024 (Doug Mills, Organiser)

Doug Mills outlined the arrangements for the next Summer School which will be held at Saxton Lodge, Stoke, the same venue as the previous Nelson Summer School. All dance venues will have wooden floors, tutors will come from New Zealand and Australia. Afternoon excursions are envisaged. Online registration will be available within the next few weeks. Pat Henley acknowledged Doug for taking on a fourth Summer School.

### Wellington 2024-25 (Ann Oliver, Organiser)

Ann Oliver outlined arrangements to date for the following Summer School, which will be held at Scots College, Strathmore Park, Wellington. Accommodation and events will be on-site, and classes nearby.

The President reported that revised job descriptions for the Management Committee positions will be presented at the next AGM.

### Pick-up 52

Andrew Uren (and later Katherine Uren) spoke about their concept (Pick-up 52) for celebrating the RSCDS Centenary, and showed a short video taken at the Summer School to demonstrate

the kind of material they are seeking from clubs. The aim is to involve as many dancers as possible, in video clips of 30 seconds to one minute, using dances devised by New Zealanders as much as possible. To date, a substantial number of clubs have indicated their interest in participating.

Michael Laidlaw proposed a vote of thanks to Linda for leading us through this meeting. AGREED BY ACCLAMATION.

The President thanked attendees for coming to the AGM and noted that Liz Hickey and her team have done a fantastic job in organising and running Summer School 2022/23. The President also thanked all speakers at this meeting, and the three outgoing Management Committee members for their contribution to the NZ Branch.

The date and venue for the next Annual General Meeting of the Royal Scottish Country Dance Society, New Zealand Branch Incorporated, will be notified to members by November 2023, likely to be 1 January 2024, at the Nelson Summer School venue.
