On behalf of the Applicant Family Group, Adult 1 signs this from and acknowledges the scholarship conditions below:

- The maximum value of the Family Scholarship is the residential fee for 2 adult RSCDS/NZ Branch members and 2 Junior Associate Members (JAMs) of the RSCDS/NZ Branch.
- The Applicant Family Group consists of at least one but no more than two adults and at least one young dancer
- The Applicant Family group may choose to attend Summer School as Commuters
- The Applicant Family Group must consist of at least one RSCDS adult member, and
 one parent/guardian these may be one and the same person, or different people (if the
 parent/guardian is not an RSCDS member, they may attend Summer School only as a non-dancing
 participant).
- The adult(s) of the Applicant Family Group who are attending Summer School as dancing
 participants must be RSCDS/NZ Branch members on 30 September of the year of application and
 at the time of New Zealand Summer School attendance
- The young dancers of the Applicant Family Group must be JAMs of the RSCDS/NZ Branch on 30 September of the year of application and at the time of New Zealand Summer School attendance
- Young dancers must be accompanied by an adult while attending Summer School. The accompanying adult does not have to be part of the Applicant Family Group
- If the total registration fee for the Applicant Family Group is less than the total value of the scholarship, the balance is retained by NZ Branch. NZ Branch may choose to award the balance to another family group
- Applicant eligibility is assessed by the current NZ Branch President
- Selection of successful applicants is a random process (i.e., it is unbiased and all applicants have an equal chance of success)
- Scholarship recipients of any one year may not apply for any category of New Zealand Summer School scholarship in the year immediately following
- Scholarship recipients must submit an article for the NZ Branch magazine on their Summer School experience. The article may also be published in the Jigs & More newsletter and Kiwi News
