### INFORMATION TECHNOLOGY

The directories on the website are set up from scratch at the beginning of the year. The best way to submit any subsequent updates such as a change of email address or class venue is to go to the email link with pre-defined recipients and subject line. Just add the details that you would like changed. For the Region directory the link is at the foot of the page. You can personalise the page with one or two images and a brief write-up about the Region. Please keep this fairly general in nature and avoid anything which is likely to become out of date. Region Secretaries might find like to download a directory and save it as Excel at the start of the year, then any changes (preferably highlighted in some way) can be sent it to the Branch.

### YOUTH

**JAM Registration and Fees** – All existing JAMS should have received their re-registration forms for 2021 and paid their fees. If you haven't or know someone who would like to register as a JAM, head to the branch website to fill in a form. We are aiming to increase the number of registered JAMS so register all juniors, including those who dance at clubs without designated junior classes.

**Summer School:** There are 2 JAM classes on offer this year at SS – Junior Jams (ages 8-13) and Senior JAMS, known as the Youth Challenge Class (ages 14-40). If JAMs from your area enjoyed the 'Spring Fling' style class at Cambridge SS then the Youth Challenge Class will be just the class for them. Remember there are 2 scholarships for JAMs to attend SS - apply by 30<sup>th</sup> June, using the form on the NZ Branch Website
